#### **Schools Back in Session**

The new school year has started and the school buses are back to pick up our young ones. Bus drivers are tasked with transporting our young ones back and forth safely, but the responsibility does not just lie with them; it lies with us too!

- Be aware of students, flashing school bus lights, and school buses:
- Slow down and obey all traffic laws;
- Watch for and obey signals from bus drivers and crossing guards;
- Be alert and watch for children near bus stops;
- Do not pass the bus;
- STOP for school buses that are loading and unloading children;

## Fall/Winter Weather

I know we are all excited for that crisp fall weather, but in anticipation, we wanted to share some reminders about seasonal furniture. By November 15, 2021, you should move your seasonal furniture inside or place it in storage. By moving these items, you keep them protected from the changes in weather conditions, and it makes it easier for staff to shovel and clear the snow.

Wondering what to do with your cooking equipment and other year-round items? You can keep them out during the fall/winter season but please keep them in your immediate stoop area or placed to the side of your patio.

## **Holidays**

Time is flying by this year and wouldn't you know it: the holiday season is fast approaching! Please see some helpful tips for the upcoming season:

Halloween is right around the corner and for anyone who has been here in years past, we often have lots of trick or treaters walking around in their costumes. Please take extra care when driving around the neighborhood; remember that not all children are being escorted by their parents while trick or treating.

## **Maintenance Increase**

We recently notified all shareholders, in an August 22, 2022 notice, of a four and a half percent (4 ½%) increase in our maintenance charges effective on October 1, 2022 with the beginning of our 2022-2023 fiscal year. In addition, due to the high fuel prices, we are instituting a Fuel Surcharge of \$3

per share over 12 months. This will be in effect from October 1, 2022, thru March 2023 maintenance payment, at which time we will reassess whether we will need to continue for the rest of the year.

## **Bulk Trash Fees**

We are excited to announce a reevaluation in our bulk trash fees. The following changes in fees are effective immediately: tv's, computers, monitors and large appliances (refrigerators, ranges/stoves, dishwashers, washing machines, dryers, air conditioners) have been reduced to \$40 each. We strongly encourage you, as you purchase new appliances, mattresses, or other large items, to arrange with your vendor to remove the old one during delivery. You will need to notify the Maintenance Staff that you will be disposing of bulk trash, so that they can arrange to meet you and unlock the shed.

## **Quick Updates!**

<u>Planting</u>: High Meadow only permits planting of items that are native to North America and non-invasive. Please refer back to our previous newsletter for more information on these types of plants and where you can find more information.

<u>Laundry Room Servicing</u>: If you need to request service on the laundry machines, please complete a maintenance slip and include the serial number, machine number and what condition the machine is in.

<u>Bike Riding</u>: Bikes should not be ridden on the lawns or on the internal walkways. Please take care when riding them in the parking lots or on the street.

<u>Water Conservation</u>: We had a little bit of rain recently but it certainly is not enough. We encourage you to do your part and continue conserving your water usage.

<u>Parking Stickers</u>: Just move in and need a parking sticker? Need to update your current parking sticker? Visit the website for an application. New shareholders have a 60 grace period to obtain their parking sticker and must be registered to your High Meadow address. In the meantime, you should notify the maintenance office of the make and model of your vehicle as well as the plate number. Vehicles without a parking sticker are subject to being towed at their owners expense.
